Categorizes the rate of incidence of hazardous conditions into three categories with different salary adjustments for each rate. Authorizes a state agency to spend appropriated funds to pay for expenses of an employee who is injured or killed while engaged in the performance of the employee's duties or whose duties require the employee to be exposed to unavoidable dangers peculiar to the employee's job responsibilities. Defines "workweek" as a fixed and regularly recurring period of seven consecutive 24 hour periods. Revises compensatory time off for state employees not serving the legislature or judicial branch. Allows state agencies to provide state employees, at the time of hiring an employee to a classified position additional compensation. Amendment Summary: House State Government Committee amendment 1 (012511) Deletes all language after the enacting clause. Authorizes commissioners of any department within the state to develop standards to identify hazardous duty positions within their department and categorize uncommon working conditions for the classification of employees as mildly, moderately, or severely hazardous in consultation with its appointing authorities and employees. Requires such commissioners to consult with the Commissioners of the Department of Finance and Administration (F&A) and the Department of Human Resources (DOHR) if such standards and categories are developed. Authorizes the appointing authority to apply to the appropriate commissioner for salary adjustments with evidence and documentation to substantiate the claim for the hazardous salary adjustment upon determination that a state employee or class of employees is eligible for such adjustment. Authorizes the commissioner to grant approval for a hazardous salary adjustment for the qualified employee. Requires each hazardous adjustment claim to be submitted as a separate application. Authorizes F&A and DOHR to audit any hazardous salary adjustment claims submitted. Authorizes state employees to receive a hazardous salary adjustment granted only for the time the employee is subject to hazardous working condition. Authorizes a hazardous salary adjustment ranging from 5 percent to 10 percent of the employee's base salary depending on the severity of hazardous conditions, which can range from mildly hazardous to severely hazardous. Requires state agencies to compensate any former state employees for any approved hazardous salary adjustment for any work performed regardless of whether the approval occurs after such employee transfers to another state agency or is separated from service. Changes effective date to 2018. Removes the sunset provision applicable to the Select Oversight Committee on TennCare. Requires the Speaker of the House to appoint the 5 required members to the Select Oversight Committee on Children's Services from the House Civil Justice Committee, rather than from the House Health Committee. Sets the number of meetings of the Select Oversight Committee on Children's Services to be twice a month during the legislative

session, rather than monthly, with other meetings being subject to the call of the chair. Adds the Department of Human Services (DHS) to the list of entities required to provide the Select Oversight Committee on Children's Services with any financial or other relevant information as it may require. Adds the DHS to the list of entities for which the Select Oversight Committee in Children's Services shall perform legislative oversight.
